## EXTRACT OF CONSTITUTION – ACADEMIC COUNCIL

### 3. Membership

(1) The Committee comprises:

- (a) the Chair of the Academic Board as Chair;
- (b) the Deputy Chair of the Academic Board;
- (c) the Associate Chair of the Academic Board;
- (d) the Vice-Chancellor or the Senior Deputy Vice-Chancellor;
- (e) the Deputy Vice-Chancellor (Research) or nominee;
- (f) the Deputy Vice-Chancellor (Education) or nominee;
- (g) five persons nominated by and from the Heads of Schools;
- (h) the Pro Vice-Chancellor (Indigenous Education);
- (i) the Dean of the Graduate Research School;
- (j) the President of the UWA Student Guild;
- (k) the President of the Postgraduate Students' Association;
- (l) ten academic staff members elected by and from the members of the Academic Board; and
- (m) up to two members co-opted by the foregoing.
