EXTRACT OF CONSTITUTION – BOARD OF GRADUATE RESEARCH SCHOOL

3. Membership

- (1) The Committee comprises:
 - (a) the Dean, Graduate Research School as Chair;
 - (b) the Chair of the Academic Board or nominee;
 - (c) five Graduate Research Coordinators nominated by the Heads of Schools;
 - (d) two academic staff members nominated and elected by the Academic Board;
 - (e) the President of the Postgraduate Students' Association or nominee;
 - (f) a Graduate Education Officer;
 - (g) the Pro-Vice Chancellor (Indigenous Education) or nominee;
 - (h) the University Librarian or nominee; and
 - (i) up to five members co-opted by the chair as required for balance or specific expertise.
