3. Membership

- (1) The Committee comprises:
 - (a) **office-bearers** comprising:
 - (i) the Chair of the Academic Board;
 - (ii) the Deputy Chair of Academic Board;
 - (iii) the Associate Chair of Academic Board.
 - (b) **ex-officio members** comprising:
 - (i) the Vice-Chancellor;
 - (ii) the Senior Deputy Vice-Chancellor;
 - (iii) the Deputy Vice-Chancellor (Education);
 - (iv) the Deputy Vice-Chancellor Research);
 - (v) the Deputy Vice-Chancellor (International);
 - (vi) Heads of Schools;
 - (vii) the Pro Vice-Chancellor (Indigenous Education);
 - (viii) the Dean, Graduate Research School;
 - (ix) the President of the Guild of Undergraduates;
 - (x) the President, Postgraduate Students' Association.
 - (c) **elected staff members** comprising:
 - (i) 39 Professors (Level E) of the University elected by the Academic Staff;
 - (ii) 21 Level A-D Academic Staff of the University elected by the Academic Staff;
 - (iii) eight persons elected by and from the Professional Staff of the University.
 - (d) **nominated students** comprising:
 - (i) four students nominated by the Student Guild Council to ensure appropriate diversity of student representation.
